Gift Aid Contributions

To save on staff time and costs (printing and postage), please now only complete Gift Aid forms **once a year** using the Gift Aid Contributions List supplied, in spring, with the Annual Return forms. A Gift Aid claim is made at several points throughout the year and HMRC allow charities to claim back the tax on donations going back 4 years, so there is no need to send us information on Gift Aid contributions every time you empty the Red Boxes.

To comply with data protection regulations, please do not email us with lists of Red Box holders containing a lot of personal information (names, addresses, telephone numbers etc.), unless the data is sent securely e.g. in a password protected file.
